Notice is hereby given that the Board of Trustees of the Hillside Public Library, pursuant to the Prevailing Wage Act, 820 ILCS 130/00.01, determined by ordinance adopted on June 15, 2022 that the general prevailing wage rate for workers engaged in this locality for laborers, mechanics, and other workers engaged in the construction of public works coming under the jurisdiction of the Hillside Public Library is the same as determined by The Department of Labor of the State of Illinois for Cook County. A copy of the ordinance and the Department of Labor determination is available for inspection at 405 Hillside Avenue, Hillside Illinois, and copies are available to any employer or association of employers, and any person or association of employees who have filed or file their names and addresses requesting copy of the same.

RESOLUTION 2023-1

A RESOLUTION DETERMINING PREVAILING WAGE RATE WITHIN THE LIBRARY FOR CERTAIN LABORERS, MECHANICS, AND OTHER WORKERS

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act (1992 820 ILCS 130/1 et seq. as amended) hereinafter “the Act,” and;

WHEREAS, the aforesaid Act requires that the Hillside Public Library investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workers in the locality of said Library, employed in performing construction of public works of said Library.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Library Trustees of the Hillside Public Library, Cook County, Illinois, as follows:

SECTION ONE

To the extent required by the Act, the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in construction of public works coming under the jurisdiction of the Hillside Public Library is hereby ascertained to be the same as the prevailing rate of wages for construction work in Cook County as determined by the Department of Labor of the State of Illinois as of June of the current year; a copy that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department’s June determination and apply to any and all public works construction undertaken by the Hillside Public Library. The definition of any terms appears in this Resolution which are also used in aforesaid Act shall be the same as in the Act.

SECTION TWO

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Hillside Public Library to the extent required by the Act.

SECTION THREE

The Hillside Public Library Board of Trustees shall publicly post or keep available for inspection by any interested party in the main office of the Library this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION FOUR

The Hillside Public Library Board of Trustees shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their

names and addressees, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION FIVE


The Hillside Public Library Board of Trustees Secretary shall promptly file a certified copy of this Resolution with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION SIX


