**A resolution establishing the budget appropriation of the Hillside Public Library for the Fiscal Year beginning May 1, 2026 and ending April 30, 2027**

**IT IS HEREBY RESOLVED** by the Board of Trustees of the Hillside Public Library, Hillside, Illinois that the following shall be adopted as the financial requirements of the Hillside Public Library for inclusion in the 2026-2027 Appropriation Bill of the Corporate Authority.
